Introduction of Leading Organiser 籌辦機構簡介

The Hong Kong Information Technology Federation (HKITF) was founded in 1980 as a not-for-profit, nonpolitical trade association to provide a forum in which the IT-related business in Hong Kong can work together for the benefit of the industry and to maintain a high level of business practice amongst the members. HKITF acts as the bridge for international IT companies looking for local partners and works with trade commissions to host trade promotion events. It supports and sponsors various IT sectors to develop focus groups; promotes local IT business through various activities; and also helps keeping members abreast of local IT developments and business opportunities. In the public sector, HKITF works closely with government to promote the development of the local IT industry. Background 背景

The Hong Kong ICT Awards (HKICTA) aims at recognising and promoting outstanding information and communications technology (ICT) inventions and applications, thereby encouraging innovation and excellence among Hong Kong's ICT talent and enterprises in their constant pursuit of creative and better solutions to meet business and social needs.

The HKICTA was established in 2006 with the collaborative efforts of the industry, academia and the Government. Organised by the Office of the Government Chief Information Officer, and led by Hong Kong ICT industry associations and professional bodies, the Awards aims at building a locally espoused and internationally acclaimed brand of ICT awards.

There are eight categories under the HKICTA 2024. There will be one Grand Award in each category, and an "Award of the Year" will be selected from the eight Grand Awards by the Grand Judging Panel. In addition, in a bid to foster the innovative use of artificial intelligence (AI), each of the eight categories will establish a new distinguished accolade: the "Best Use of AI" award, magnifying and honouring outstanding achievements in harnessing the power of AI in respective areas.

香港資訊及通訊科技獎旨在表揚及推廣優秀的資訊及通訊科技發明和應用,以鼓勵香港業界精英和企業不斷追求創新和卓越,謀求更佳和更具創意的方案,滿足企業的營運需要,造福社會。

通過業界、學術界和政府的共同努力,香港資訊 及通訊科技獎於二零零六年成立。香港資訊及通 訊科技獎由政府資訊科技總監辦公室舉辦,並由 香港業界組織及專業團體籌辦,目的是為香港建 立一個廣受香港社會愛戴、並獲國際認同的資訊 及通訊科技專業獎項。

2024香港資訊及通訊科技獎設有八個類別的獎項。每個類別均設有一個大獎,而最終評審委員會會再從八個大獎中甄選出「全年大獎」。此外,為了激發更多人工智能的創新應用,每個獎項類別都會增設一個嶄新獎項:「最佳人工智能應用」獎,以彰顯並表揚那些在相關範疇應用人工智能方面取得傑出成就的參賽作品。



Objective 目的

- To recognise outstanding products and solutions that promote and facilitate a smart mode of enjoyable and convenient living through capitalising on ICT advancements
- To promote greater use of ICT in the area of promoting smart living and lifestyle in the community
- To encourage local original and creative ICT development for betterment of our life
- To educate the community about the importance of ICT in their daily lives

Prizes and Benefits for Winners 得獎者的獎勵

The remarkable achievements of the Awards winners (Gold/Silver/Bronze) will be recognised by customers, organisations, the ICT industry practitioners and across the community. Winners will be entitled –

- to receive trophies (Gold/Silver/Bronze) of the HKICTA;
- to display the official logo of the HKICTA in their promotional materials;
- to participate in various promotional campaigns to publicise their achievements;
- to be supported for entering into other regional and international awards and competitions;
- to 3 months free access to Lion Rock 72 (co-working space in InnoCentre) or co-working space in Hong Kong Science Park Incubation Centre for SMEs¹;
- to participate in investment matching activities coorganised by the Hong Kong Business Angel Network (HKBAN) and Hong Kong Science and Technology Parks Corporation (HKSTPC);
- to 3 months free access to Flexi Space in Cyberport Smart-Space for SMEs²;
- to receive Green Channel Interview (conditional³) offer of "HK Tech 300 Seed Fund" by City University of Hong Kong (CityU). The awardee will receive up to HKD100,000 in funding and other support from the programme (https:// www.cityu.edu.hk/hktech300/about-hk-tech-300/hktech-300-seed-fund) (For Student Innovation category, only Stream IV "Higher Education" winners are eligible) after passing through the interview; and
- to free participation in some large-scale local ICT events (e.g. InnoEX) for marketing exposure.

- 「香港科技園公司為榮獲「2024香港資訊及通訊科技獎」金/銀/銅獎的中小企業提供一個免費名額,使用創新中心內的初創協作基地「Lion Rock 72」或位於香港科學園培育中心的共享工作空間三個月(由香港科技園公司分配,視平情況而定)。
- 數碼港為榮獲「2024香港資訊及通訊科技獎」金/銀/銅獎的中小企業提供 一個免費名額,使用數碼港共享工作空間Smart-Space內的靈活辦公桌三 個月。共設32個名額,會以先到先得的方式安排。獎項公布後,獲獎中小企業需於2025年3月31日或之前提交申請,逾時遞交的申請將不獲處理。

- ² Cyberport offers 1 free Flexi Space in Cyberport Smart-Space for 3 months to SMEs who are HKICT Awards 2024 Gold, Silver or Bronze award winners. The number of flexi-desk offered to ICT Winners is capped to 32. Given the quota, flexi-desk will be offered on a first-come-first-served basis and subject to the availability. Winner shall submit application to Cyberport for the offered flexi-desk on or before 31 Mar 2025 after the announcement of results. Any submission after the deadline will become ineligible.
- 3 1. Either one of the startup's founders is associated with CityU, such as a student / alumnus / research assistant; or 2. General Eligibility Requirements 一般參賽資格

- The applicant must have the intellectual property right and/ or legitimate right over the ICT product/service mentioned in the application. The applicant shall disclose disputes any place over the world over intellectual property right about the applicant's ICT product/service, if any, for the Leading Organiser to consider eligibility of the application.
- The application must be submitted by locally (Hong Kong) registered entities (please enclose Company/Business Registration proof) or residents in Hong Kong⁴ at the time of closing for entry enrolment.
- 3. A significant part of the innovation, design, research and development (R&D) of the mentioned ICT product/service must come from resources in Hong Kong. The applicant should demonstrate significant value-add by the Hong Kong resources contributing to the success of the ICT product/service in the target market.
- 4. With the exception of the Student Innovation category, the submitted product/service must have been available⁵ in the market for at least 3 months or in live operation for at least 3 months at the time of closing for entry enrolment (please enclose proof e.g. delivery note, invoice, public announcement, advertisement, internal announcement, etc.).
- 5. The same application is only allowed to be submitted to a maximum of ONE award stream among all the Categories. Any application found to have entered into more than one award stream will be disqualified.
- Winning entries of the Gold/Silver/Bronze award in previous years of the HKICT Awards can enter the Awards again only if there is significant change or enhancement in the product/service, or for a new award category.
- 4 "Residents in Hong Kong", in the context of HKICT Awards, include both permanent and non-permanent residents. If an entry is submitted by more than one person, at least half of the members of the group must be Hong Kong resident. For the case of Student Innovation category, certification of Hong Kong resident status can be performed through certifying student status collectively by concerned educational institution.
- Examples are applications and products already in the market, application systems deployed internally in a company, and mobile solutions available at App Stores. For startup companies competing for ICT Startup Award, prototypes appear only on kickstarter or similar platforms are NOT considered as available in the market.

- 參賽者必須在截止報名時為香港註冊公司(請 附上公司/商業登記證明)、機構或香港居民⁴。
- 3. 參賽的資訊及通訊科技產品/服務項目在創新、設計和研究發展方面的重要部分必須源自香港。參賽者須展示香港資源為其資訊及通訊科技產品/服務帶來顯著增值,促使有關項目在目標市場取得成功。
- 4. 除學生獎項類別外,參賽的資訊及通訊科技產品 /服務項目必須在截止報名日期前已經在市場上 公開發售最少三個月/或開放予下載應用⁵或已 經投入運作最少三個月(請附上證明 — 例如送 貨單、發票、外發公告、廣告、內部通告等)。
- 5. 同一參賽項目只可參加各獎項類別的其中一個 獎項組別。任何項目如被發現報名參加多於一 個獎項組別,將被取消資格。
- 6. 過往香港資訊及通訊科技獎金、銀、銅得獎項目的產品/服務,必須已作出重大修改或優化,或參加另一個獎項類別,方可再次參賽。
- 4 在香港資訊及通訊科技獎的準則下,「香港居民」包括永久居民和非永久居 民。如參賽項目由多於一人的組織申請,該參賽組織至少有一半成員必須 是香港居民。學生創新獎方面,香港居民身份可由相關學校以統一證明學 生身份的方法代替。
- 5 例如該資訊及通訊科技產品/服務項目已經投入於市場,該應用程式已被應用於公司內部的系統,以及該流動解決方案已於App Stores 可供下載。至於競逐資訊科技初創企業獎的初創公司,如其原型樣辦只在kickstarter或類似平台上出現,將不會被視為已投入於市場。

Rules and Regulations 參賽規則

- Applicants are advised to be aware of the best practice and case-based experience as promulgated by the Office of Privacy Commissioner for Personal Data.
- Applicants are reminded that any person who, without the permission of Steering Committee of Hong Kong ICT Awards, offers an advantage to parties involved in the Awards as a reward or inducement for doing any act or showing favour in relation to the Awards commits an offence of the Prevention of Bribery Ordinance (Cap. 201).
- To avoid conflicts of interest and the perception as such, applications for the Awards from sponsors will not be accepted.
- 4. In case of any dispute, the decision of the Leading Organiser will be final and binding on all parties concerned.

Award Streams 獎項組別

1. Smart Healthcare

- (i) any ICT-based products, services, applications, websites or programs which demonstrate the use of Al or innovative technologies can improve personal health and well-being. These may include medical news websites/ applications/ products, health information, and online diagnosis. Health includes not only medicine but also includes fitness, alternative and mental health, family activities, senior care, marital and parenting etc.
- (ii) any ICT-based products, services, applications, websites or programs which demonstrate the use of AI or innovative technologies can encourage and make our lifestyle more eco-friendly.

2. Smart Home

(i) any ICT-based devices, products, services, applications, websites or programs which demonstrate the use of AI or innovative technologies to bring improvements to home environment for a better, safer and healthier living, including but not only home automation, smart lighting, air and water quality monitoring, energy efficiency control, wellness monitoring, smart parking, surveillance, security system, property management, and affiliated Club House management, etc.

3. Smart Lifestyle

- (i) any ICT-based products, services, applications, websites or programs which demonstrate the use of Al or innovative technologies can give to an easy and comfortable indulgence of the appetites and the finer things in life, such as in area of Art, Music, Fashion and Beauty, Entertainment, Game, Travel & Tourism, Food and wine, Sports and Hobbies etc.
- (ii) any ICT-based products, services, applications, websites or programs which demonstrate the use of AI or innovative technologies can facilitate learning in new, innovative & interactive style and can encourage citizens of the all ages to become multifaceted life-long learner, such as: website offering informative content for online learning; locally produced hardware that facilitates learning via the network e.g. tablet PCs, smart phones; applications such as mobile or online applications that provide good learning experience or helps users better acquire or use the learning materials/content more effectively; or learning materials such as e-books, multimedia based learning or training materials etc.

1. 智慧醫療

- (i) 任何人工智能或通訊及資訊科技開發,鼓勵有助改善個人健康的應用系統/產品/網站,包括醫療新聞網站/應用/產品、健康資訊和網上診斷。醫療包括醫藥、健身、精神健康、家庭活動、長者護理、婚姻及育兒等。
- (ii) 有助推廣健康、環保及高質素生活方式的 應用系統/產品/網站。

2. 智能家居

(i) 任何人工智能或通訊及資訊科技開發的應用程式/網站/產品/解決方案/服務,有助發展創新技術以達致提升(或改善)家庭環境的舒適度,安全性和健康生活質素,包括家居自動化、智慧生活、智能照明、空氣及水質管理、能源效能控制、健康管理、智能泊車、監控、安全系統、屋苑、附屬會所管理等。

3. 生活時尚

- (i) 任何人工智能或通訊及資訊科技開發的應用程式/網站/產品/服務,有助提供舒適及高質素生活方式,如藝術、音樂、時尚和美容、娛樂、遊戲、旅遊、食品及酒、運動和興趣等。
- (ii) 提供新穎及創新的學習模式的資訊及通訊 科技的應用系統/產品/網站,以鼓勵全民 終身學習,包括:
 - 提供網上學習內容的網站。
 - 本地生產的硬體以助透過網絡學習,例 如:平板電腦,智能手機等。
 - 提供良好的學習經驗或協助使用者更有效地獲得及使用學習資料及內容的手機或網上應用程式。
 - 電子學習素材如多媒體教學或培訓材料。
